## CLAUSE 1

### PROVIDER OBLIGATION

1. Provide thorough training on system functionality to **RESELLER**.
2. Maintain and guarantee a 99% uptime cloud service to **RESELLER's** clients for their operations.
3. To explore new features and add-ons that will enhance the software and help **RESELLER** to make more sales.
4. To provide continuous improvement to the software and perform through testing to ensure each update will not cause interruption to **RESELLER's** clients' activity
5. Provide Tier# 2 Technical Support for software and compatible hardware to **RESELLER's** customers.
6. Redirect relevant leads from **Reseller's** Region and forward any contact information & not compete with **RESELLER** in this region.
7. Provide materials related to the Product for **RESELLER** for building website and sales + marketing purpose.

## CLAUSE 2

### PROVIDER BENEFIT

1. **PROVIDER** will get new clients / subscribers from **RESELLER**
2. **PROVIDER** will earn ongoing revenue share from **RESELLER's** client subscription.

## CLAUSE 3

### RESELLER OBLIGATION

1. Actively promote Deal POS with **RESELLER** value-added services.
2. Provide Tier #1 first contact support and services to **RESELLER's** client.
3. **RESELLER** must pay a one time fee of USD 100 For entry fee to the **RESELLER** program.

#### CLAUSE 4

### RESELLER BENEFIT

1. Featured placement in **PROVIDER's** website as a promotional benefit.
2. One subscription of DealPOS for **RESELLER** which is to be used internally at no cost

#### CLAUSE 5

### REVENUE SHARING

1. **RESELLER** agrees on the following revenue sharing from **PROVIDER** for all active accounts  
25% REVENUE SHARING for **RESELLER** payable at the end of the month

#### CLAUSE 6

### BILLING PAYMENT

1. Client's Billing accounts must be paid by **RESELLER** not by individual clients.
2. **RESELLER** is responsible of collecting client's payment at the beginning of every month.
3. Payment can be done using VISA / Master credit card via PayPal Gateway  
(<https://www.paypal.me/dealpos>) under the name PT. Generasi Inspirasi Informatika
4. Payment to **PROVIDER** must be done in USD Currency
5. **RESELLER** is not charged for idle accounts, this includes inactive accounts due to cancellations or nonpayment of subscriptions by customers.

#### CLAUSE 7

### DISPUTES AND TERMINATION OF AGREEMENT

1. Either party may terminate this agreement for reasons of failing the clauses mentioned with one month notice
2. **RESELLER** reserves the right to keep all acquired clients in the event of agreement termination.
3. **RESELLER** agrees to provide 1 month notice before agreement termination to provide necessary support / advice for clients who do decide to keep using our POS SOFTWARE without local Support available.

This terms of agreement is signed on the day and date mentioned at the beginning of the agreement, where both parties agree to be bounded by the clauses introduced in the agreement.
